Sir/Madam,

I am directed to refer to the Ministry's order No.R.12011/58/2015-EP (IM-1) for 2017-18 dated- 14.08.2017 related to admission matter for the year 2017-18 intimating certain shortcomings for rectification for consideration of the case for the academic session 2018-19.

2. The CCIM had carried out an inspection of the institution on 06.02.2018 and re-visited on 21-22.05.2018 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Ministry. On examining the same, it was observed that the Clinical teacher in each of Kayachikitsa, Panchkarma, Shalya and Shalakya Dept., Yoga Teacher, Web based computerised central registration system in OPD/IPD, Quality testing lab, Computer & Printer in teaching dept., 75 % instruments in Dravyaguna and Shalakya (Opthalmic & ENT-Surgical), Functional X-Ray, ECG and USG units and Aadhaar based Geo location enabled attendance system for teaching staff, non-teaching staff, hospital staff were not available. Therefore, under provisions of the first proviso to sub-section (5) of Section 13A of the IMCC

Act, 1970, an opportunity of hearing was granted to the college on 21.08.2018 to present the case.

- 3. The observation of hearing Committee based on submission made by the college representatives during hearing and recommendations & visitation report of the CCIM have been carefully examined in terms of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, provisions under the IMCC Act, 1970, relevant regulations made thereunder, and as per approved Standard Operative Procedures (SOPs) it is found that College is fulfilling notified and approved criterion for granting conditional permission for UG (BAMS).
- 4. It has been decided by the Central Government for grant of conditional permission to the Shree Ram Ayurvedic Medical College and Hospital, Vill.- Dungrawali, Partapur Bye-Pass Road (Delhi- Haridwar Highway), Meerut- 250103 Uttar Pradesh with 60 seats in UG (BAMS) course for the academic session 2018-19 under section 13C/13A of the IMCC Act, 1970 subject to the condition that college shall fulfill the deficiencies as mentioned below by 31st December, 2018:
 - (i) Aadhaar based Geo location enabled attendance system for teaching staff, non-teaching staff, hospital staff as per RMS, 2016.
 - (ii) Quality Testing Lab in College.
 - (iii) Functional USG unit in Hospital.
- 5. In addition, following requirements should be fulfilled by the college by 31st December, 2018 to get conditional permission for the session 2019-20:
 - (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
 - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
 - (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*, and

- 6. The fulfillment of the conditions attached to the permission given above may be made within the time period specified and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCIM also.
