The recommendations and visitation report of the CCIM have been carefully examined in terms of Sub-regulation (4) of regulation 10 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, provisions under the IMCC Act, 1970 & relevant regulations made thereunder and as per approval of the Hon'ble MoS (IC) for the UG/PG course(s) for grant of conditional permission for the academic session 2017-18 vide Ministry's letter No.R.11011/03/2017-EP (IM-1) dated 12.06.2017, it is found that the College is fulfilling the notified and approved criteria for granting conditional permission.

The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2018-19.
